SINCE JANUARY 2022, THE PHARMACISTS' SOCIETY OF LATVIA HAS BEEN REPRESENTED IN THE COUNCIL OF INDUSTRY EXPERTS.

ON JANUARY 26, THE PHARMACEUTICAL WORKING GROUP STARTED ITS ACTIVITY WITHIN THE EXPERT COUNCIL OF THE CHEMICAL INDUSTRY AND ITS RELATED INDUSTRIES (CHEMISTRY, PHARMACEUTICALS, BIOTECHNOLOGY, ENVIRONMENT) COORDINATED BY THE CONFEDERATION OF LATVIAN EMPLOYERS. UNTIL THEN, PHARMACY WAS NOT SEPARATELY REPRESENTED IN THE COUNCIL OF INDUSTRY EXPERTS. ONE OF THE GOALS OF THE PHARMACISTS' SOCIETY OF LATVIA IS TO DEFEND THE PROFESSIONAL INTERESTS OF PHARMACISTS AND TO IMPROVE THEIR QUALIFICATIONS, WHICH IS CLOSELY RELATED TO THE COMMON GOALS OF INDUSTRY EXPERT COUNCILS.
